CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KRAEMER PROPERTIES, LLC 13523 MARQUAM ROAD NE MT ANGEL, OREGON 97362

confirms the right to use the waters of ABIQUA CREEK, tributary to the PUDDING RIVER, for IRRIGATION of 175.4 ACRES.

This right was perfected under Permit S-13619. The date of priority is APRIL 25, 1939. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.19 CUBIC FEET PER SECOND, if available at the original point of diversion (SW¼ NW¼, SECTION 24, T 6 S, R 1 W, W.M., WALKER DITCH - 53.5 CHAINS SOUTH AND 33.0 CHAINS EAST FROM THE NW CORNER OF S. ALLEN DLC 50), or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
