CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DESMOND D SIEG
BAKER OR 97814

confirms the right to use the waters of MILL CREEK, tributary to SALMON CREEK, for SUPPLEMENTAL IRRIGATION of 92.20 ACRES.

This right was perfected under Permit S-26507. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.30 CUBIC FEET PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion. The date of priority is DECEMBER 28, 1959, for 1.17 cfs and DECEMBER 29, 1959, for 1.13 cfs.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.50 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.


A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 33795, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on October 28, 1996, and recorded in Special Order Volume 50 page 735, approving a petition by Kerns Brothers Inc. under ORS 541.329 for mapping water rights within a district. This Certificate along with Certificate 72616 supersedes Certificate 33795.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
