CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORMAN BUTLER RT 1 BAKER OR 97814

confirms the right to use the waters of THREE GRAVEL PITS in the PINE CREEK (POWDER RIVER) BASIN for IRRIGATION of 61.4 ACRES and SUPPLEMENTAL IRRIGATION of 113.7 ACRES.

This right was perfected under Permit G-2877. The date of priority is APRIL 14, 1965. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.16 CUBIC FEET PER SECOND (CFS); being 1.23 CFS FROM PIT NO. 1; 0.72 CFS FROM PIT NO. 2; AND 0.21 CFS FROM PIT NO. 3, or its equivalent in case of rotation, measured at the wells (gravel pits).

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH, of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
