This right was confirmed by decree of the Circuit Court for the State of Oregon for Jackson County. The decree is of record at Salem in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1852.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.00 cubic feet per second, or the equivalent in case of rotation, measured at the point of diversion.

This certificate corrects a scrivener's error in Certificate 82048 that incorrectly described the amount of water to which the right is entitled.

This certificate describes that portion of the water right confirmed by Certificate 48362, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director in PC 95-4 entered February 29, 1996, and recorded in Special Order Volume 50, Page 303, approving a partial cancellation of a water right. This certificate supersedes Certificate 82048.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
