The water user shall maintain a fish screen or fish by-pass device. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife and shall be installed under the supervision of the Department of Fish and Wildlife.

This certificate is issued to confirm a change in POINT OF DIVERSION, CHARACTER OF USE, and PLACE OF USE approved by an order of the Water Resources Director entered MARCH 20, 2003, and supersedes Certificate 49476, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein is subject to the existing minimum flow policies established by the Water Resources Policy Review Board.
