CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL a tributary of BUTTER CREEK for the purpose of IRRIGATION OF 147.3 ACRES.

The right has been perfected under Permit G-2276. The date of priority is OCTOBER 8, 1962. The right is limited to not more than 1.15 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SW 1/4, SECTION 26, T 2 N, R 27 E, W.M.; 1870 FEET NORTH AND 1290 FEET EAST FROM THE SW CORNER, SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.


The pump system shall include an access port for measuring the water level, and an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled.
