confirms the right to use the waters of DOG CREEK AND DOG LAKE RESERVOIR, CONSTRUCTED UNDER PERMIT R-10626, tributaries of DREWS CREEK, for FISH-WILDLIFE PRODUCTION, RECREATION, ROAD CONSTRUCTION AND MAINTENANCE.

This right was perfected under Permit S-49677. The date of priority is JUNE 18, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.42 CUBIC FEET PER SECOND (CFS) FROM DOG CREEK FOR FISH-WILDLIFE PRODUCTION AND RECREATION AND 0.008 CFS FROM DOG CREEK AND NOT TO EXCEED 6.0 ACRE FEET ANNUALLY FROM DOG LAKE RESERVOIR FOR ROAD CONSTRUCTION AND MAINTENANCE, or its equivalent in case of rotation, measured at the point of diversion.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
