CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of EAST FORK EVANS CREEK, AND SUPPLEMENTAL SUPPLY FROM SPIGNET CREEK, A TRIBUTARY OF EAST FORK EVANS CREEK, a tributary of EVANS CREEK, for IRRIGATION OF 12.2 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1892. FOR EAST FORK EVANS CREEK and 1871 FOR SPIGNET CREEK.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.234 CUBIC FOOT PER SECOND FROM BOTH SOURCES, SUBJECT TO THE PROVISIONS OF PARAGRAPH 79 OF SAID DECREE or its equivalent in case of rotation, measured at the point of diversion from the source.
