CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of KILLAMACUE LAKE RESERVOIR, tributary to KILLAMACUE CREEK, for SUPPLEMENTAL IRRIGATION OF 195.7 ACRES AND STOCK USE.

This right was perfected under Permit S-17891. The date of priority is AUGUST 22, 1900. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 39.52 ACRE FEET FOR EACH IRRIGATION SEASON, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

This appropriation shall be limited to a total quantity not to exceed one-fourth of the total storage in Killamacue Reservoir or a maximum of 39.52 acre-feet, provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation established by court decree. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
