CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Killamacue Land Reservoir and Rock Creek Irrigation Company Haines, Oregon 97833

confirms the right to use the waters of KILLAMACUE LAKE AND RESERVOIR, tributary to KILLAMACUE CREEK for SUPPLEMENTAL IRRIGATION OF 745.79 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 6, at Page 291. The date of priority is AUGUST 22, 1900.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 233.82 ACRE FEET, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

This appropriation shall be limited to a total quantity not to exceed three-fourths of the total storage in Killamacue Reservoir or a maximum of 233.82 acre feet on Tract 1 and a maximum of 38.42 acre feet on Tract 2. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.



This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
