This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

confirms the right to use the waters of TWO WELLS in the KLAMATH BASIN for GROUP DOMESTIC FOR 15 FAMILIES, BACK-UP DOMESTIC SUPPLY FOR 67 FAMILIES, IRRIGATION OF LAWNS AND GARDENS NOT TO EXCEED ONE-HALF ACRE PER LOT AND NOT TO EXCEED A TOTAL OF 20.0 ACRES.

This right was perfected under Permit G-9079. The dates of priority are NOVEMBER 21, 1979 AND OCTOBER 17, 1980. This right is limited to 0.27 CUBIC FOOT PER SECOND (CFS), being:

- 0.02 CFS FOR GROUP DOMESTIC FOR 15 FAMILIES FROM WELL 1, WITH PRIORITY OF OCTOBER 17, 1980;
- 0.12 CFS FOR BACK-UP GROUP DOMESTIC FOR 67 FAMILIES FROM WELL 2, WITH PRIORITY NOVEMBER 21, 1979;
- 0.25 CFS FOR IRRIGATION FROM WELL 1, WITH PRIORITY OCTOBER 17, 1980, AND BACK-UP IRRIGATION FROM WELL 2, WITH PRIORITY NOVEMBER 21, 1979;

The wells are located as follows:

WELL 1: NW¼ SW¼, SECTION 6, T 39 S, R 10 E, WM; 62 FEET SOUTH AND 36 FEET EAST FROM THE W¼ CORNER, SECTION 6.

WELL 2: NW4 SW4, SECTION 6, T 39 S, R 10 E, WM; 4 FEET SOUTH AND 20 FEET EAST FROM THE W4 CORNER, SECTION 6.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. Irrigation is limited to lawns and gardens not to exceed ½ acre per lot. The total irrigation shall not to exceed 20.0 acres.

A description of the place of use to which this right is appurtenant is as follows:

NE¼ SE¼ SECTION 1 TOWNSHIP 39 SOUTH, RANGE 9 EAST, W.M.

LOT 6 (NW4 SW4) SECTION 6 TOWNSHIP 39 SOUTH, RANGE 10 EAST, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works shall include an airline and pressure gauge or an access port for a measuring line, adequate to determine the water level elevation in the well at all times.

The water user shall maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described. The use of water shall be limited when it interferes with any prior surface or ground water rights.
