CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PAUL A. AND DONNA L. CRABILL 42719 MARBLE CREEK RD. BAKER CITY, OR 97814

confirms the right to use the waters of A SUMP WELL AND DRAIN TIELS in the MARBLE CREEK BASIN, for SUPPLEMENTAL IRRIGATION of 153.95 ACRES.

This right was perfected under Permit G-8150. The date of priority is MARCH 28,1978. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.92 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

A description of the place of use to which this right is appurtenant is as follows:
