## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of NORTH UMPQUA RIVER, tributary to UMPQUA RIVER, for IRRIGATION of 8.97 ACRES.

This right was perfected under Permit S-8700. The date of priority is SEPTEMBER 24, 1928. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.111 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the NORTH UMPQUA RIVER, tributary to the UMPQUA RIVER for IRRIGATION of 0.24 ACRE.

This right was perfected under Permit 8700. The date of priority is SEPTEMBER 24, 1928. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.003 CUBIC FOOT PER SECOND, if available at the original point of diversion, NE4 NE4, SECTION 32, T 26 S, R 6 W, W.M.; 1125 FEET SOUTH AND 10 FEET WEST FROM THE NE CORNER OF SECTION 32, or its equivalent in case of rotation, measured at the point of diversion.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water use shall maintain a fish screen or by-pass device, as appropriate, at the new point of diversion.

This certificate is issued to confirm a CHANGE IN POINT OF DIVERSION approved by an order of the Water Resources Director entered May 11, 2007, at Special Order Volume 72, Page 42, approving Transfer Application 9548, and together with Certificate 83266, supersedes Certificate 76999, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 76999 and any related decree.
