Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

POWDER VALLEY WATER CONTROL DISTRICT
P.O. BOX 189
NORTH POWDER, OREGON 97867

confirms the right to use the waters of ANTHONY CREEK, a tributary of the NORTH POWDER RIVER, for IRRIGATION OF 38.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UNION County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 252. The date of priority is 1908.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed a rate of flow of 1.00 cubic feet per second from March 1st to July 1st and 0.48 cubic feet per second from July 1st to October 1st of each year; the total quantity diverted during each irrigation season not to exceed 95 acre feet.

The points of diversion are located as follows:

CARNES DITCH NORTH FORK - SW 1/4 NW 1/4, SECTION 13, as projected in T 6 S, R 37 E, WM; 1795 FEET SOUTH AND 4365 FEET WEST FROM THE NE CORNER, SECTION 13.

CARNES DITCH SOUTH FORK - SW 1/4 NW 1/4, SECTION 13, as projected in T 6 S, R 37 E, WM; 2461 FEET SOUTH AND 4500 FEET WEST FROM THE NE CORNER, SECTION 13.

COUGHANOUR DITCH - NE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 18, T 6 S, R 38 E, WM; 1300 FEET SOUTH AND 2400 FEET EAST FROM THE NW CORNER, SECTION 18.

A description of the place of use to which this right is appurtenant is as follows:

SW $\frac{1}{4}$ NW $\frac{1}{4}$	10.0 ACRES
SE $\frac{1}{4}$ NW $\frac{1}{4}$	4.0 ACRES
NE $\frac{1}{4}$ SW $\frac{1}{4}$	20.0 ACRES
NW $\frac{1}{4}$ SW $\frac{1}{4}$	4.0 ACRES

SECTION 22

TOWNSHIP 6 SOUTH, RANGE 38 EAST, W.M.

The quantity of water diverted at the Coughanour Ditch, together with that diverted at the Carnes Ditch, shall not exceed the quantity of water available at the Carnes Ditch under the subject right.

The diversion works shall include a headgate, an in-line flow meter, a weir, or other suitable device for measuring the water and the type and plans of the headgate and measuring device must be approved by the Watermaster before the beginning of construction work and the weir or measuring device be installed under the general supervision of the watermaster.


This certificate is issued to confirm AN ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 29, 1989, approving Transfer 6219, to correctly describe the locations of the Carnes Ditch diversions, and supersedes Certificate 1539, State Record of Water Right Certificates.

This certificate is also issued to correctly describe the certificate being superceded and supercedes Certificate 83313.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
