CERTIFICATE OF WATER RIGHT

This is to Certify. That MRS. IRIS G. ANAWALT

has a right to the use of

the waters of (SEE BELOW)

for the purpose of Irrigation & Stock

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Kalheur County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 9, at page 1; that the priority of the right thereby confirmed dates from 1875 for Tract #1; 1883 for Tract #2; 1888 for Tract #3; 1877 for Tracts #4 and #5; and Tract #6 without date of priority

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceedereinafter described

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

TRACT #1: From Jordan Creek, for irrigation of the following lands, and shall not exceed 2 acre feet per acre prior to June 1st, and \(\frac{1}{2} \) acre foot per acre during any calendar month after June 1st, of each irrigation season from April 1st to October 15th:

31 acres in SWANNA, 51 acres in SEANNA, Section 6, 27 acres in SWANNA (Lot 5), 25 acres in SEANNA, Section 5, T. 30 S., R. 46 E., W.M., being a total of 114 acres.

(NOTE: Tracts Nos. 2-5, inclusive, were allowed the same quantity of water as set forth under Tract #1.)

TRACT #2: From Jordan Creek, for irrigation of the following lands:

16.2 acres in NEINW1, 20.4 acres in NW1NW1, Section 5, 6 acres in NEINE1, 4 acres in NW1NE1, Section 6, T. 30 S., R. 46 E., W.M. 20 acres in NW1NW1, 40 acres in SW1NW1, 40 acres in NW1NW1, 37 acres in SW1NW1, Section 52, 5 acres in NEINE1, 3 acres in NW1NE1, 40 acres in SW1NE1, 40 acres in SW1NE1, 40 acres in SELSE1, 40 acres in NEISE1, 39 acres in NW1SE1, 40 acres in SELSE1, Section 31, T. 29 S., R. 46 E., W.M., being a total of 429.6 acres.

TRACT #3: From Hooker Creek, for irrigation of the following lands:

20 acres in NW 100 4, Section 32, 5 acres in NE NE 4, 3 acres in NW 10E 4, 40 acres in SW 10E 4, 40 acres in SE NE 4, Section 31, T. 29 S., R. 46 E., W.M., being a total of 108 acres.

(This right is supplemental to right from Jordan Creek for the above land through the Anawalt and Sharpe Ditch.)

TRACT #4: From prings rising on lands tributary to Cow Creek, for irrigation of the following lands:

11.6 acres in NELSEL, Section 16, 35.3 acres in SWNWL, 15 acres in SELWL, 40 acres in NELSWL, 40 acres in NELSWL, 40 acres in NELSWL, Section 15, T. 29 S., R. 44 E., W.M., being a total of 141.9 acres.

FRACT #F: From Natural Springs on land and Hawkins Spring in NW 55W 1, Sec. 11, T. 29 S., R. 44 E., W.M., for irrigation of the following lands:

25.8 acres in NEINE, 23.2 acres in SWINE, 30.5 acres in SEINE, Section 15, 38 acres in SEINE, Section 10, T. 29 S., R. 44 E., W.M., being a total of 117.5 acres.

(NOTE: Tracts Nos. 4 and 5 also cover the right to divert and use water for stock and domestic purposes throughout the year, provided the amount so diverted and used shall not exceed the rate of one-fortieth of one cubic foot per second for each one thousand head of stock outside of the irrigation season, and during the irrigation season shall not be entitled to divert any water for stock and domestic purposes in addition to the amount which they are entitled to divert for irrigation ruroses.)

The following are willow and rye grass lands, allowed a right by said decree, without date of priority, with the provision that such lands should be entitled to 2 acre feet of water per acre prior to June 1st of each year, and should not receive water thereafter:

24.3 acres in NEINWI, 18.8 acres in NWINWI, 12 acres in SWINWI, 14 acres in SEINWI, Section 5, 33.5 acres in NEINEI, 30 acres in NWINEI, 5 acres in SWINEI, 5 acres in SEINEI, Section 6, T. 30 S., R. 46 E., W.M., being a total of 142.6 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
