CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the SOUTH SANTIAM RIVER, AND RESERVOIR CONSTRUCTED UNDER APPLICATION R-45202, PERMIT R-5151, a TRIBUTARY of the SANTIAM RIVER, for MUNICIPAL USE.

This right was perfected under Permit 33198. The date of priority is MAY 29, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

SOUTH SANTIAM RIVER: NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 55, SECTION 19, T 12 S, R 1 W, W.M.; 1430 FEET NORTH AND 1050 FEET EAST FROM THE W 1/4 CORNER, SECTION 19.

LAKE OUTLETS: WAVERLY: NE 1/4 SE 1/4, SECTION 5, T 11 S, R 3 W, W.M.; 2370 FEET NORTH AND 215 FEET WEST FROM SE CORNER, SECTION 5; and

TIMBER-LINN: SW 1/4 SE 1/4, SECTION 4, T 11 S, R 3 W, W.M.; 870 FEET NORTH AND 2430 FEET WEST FROM SE CORNER, SECTION 4.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


