CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MILL CREEK, tributary to OCHOCO CREEK, for IRRIGATION OF 108.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 325. The date of priority is 1868.


The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.36 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 75204, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director, entered May 25, 2007, and recorded in Special Order Volume 72, Page 106, approving partial cancellation and supercedes Certificate 75204.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
