

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HOWARD AND GLADYS GIBSON  
ROUTE 3  
JUNCTION CITY, OREGON 97448

confirms the right to use the waters of HULBERT LAKE, a tributary of the LONG TOM RIVER for IRRIGATION OF 40.0 ACRES.

This right was perfected under Permit 33353. The date of priority is MARCH 11, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.47 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

HULBERT LAKE: SE 1/4 SE 1/4, SECTION 11, T 15 S, R 5 W, W.M.; 830 FEET NORTH AND 1280 FEET WEST FROM SE CORNER, SECTION 11.

HULBERT LAKE: SE 1/4 SE 1/4, SECTION 11, T 15 S, R 5 W, W.M.; 560 FEET NORTH AND 1020 FEET WEST FROM SE CORNER, SECTION 11

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of a second cubic foot a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SE 1/4 12.8 ACRES  
SECTION 11

SW 1/4 SW 1/4 3.0 ACRES  
SECTION 12

NE 1/4 NW 1/4 7.4 ACRES  
NW 1/4 NW 1/4 16.8 ACRES  
SECTION 13

TOWNSHIP 15 SOUTH, RANGE 5 WEST, W.M.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.


This certificate describes that portion of the water right confirmed by Certificate 38134, State Record of Water Right certificates, NOT modified by the provisions of an order of the Water Resources Director entered AUGUST 5, 1985, approving Transfer 5649.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
