confirms the right to use the waters of A SPRING and SEEPAGE, tributaries to UMATILLA RIVER, for SUPPLEMENTAL IRRIGATION of 10.0 ACRES.

This right was perfected under Permit S-20388. The dates of priority are JUNE 18, 1951 for 0.25 cubic foot per second (cfs) and JULY 1, 1952, for 0.25 cfs. The amount of water to which the right is entitled is limited to an amount actually beneficially used for the said purposes and shall not exceed 0.50 cfs, being 0.285 cfs from the spring and 0.215 cfs from seepage or its equivalent in case of rotation, measure at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-TWENTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:
