This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WASCO County. The decree is recorded in the Order Record of the STATE ENGINEER in Volume 7, at Page 406. The date of priority is 1900.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

That the pumping plant and related works shall include a weir or other suitable device for measuring the water to which the water user is entitled.

That the plans of the weir or other suitable device be approved by the Watermaster of Wasco County, Oregon, and that the weir or measuring device be installed under the general supervision of said Watermaster.
