A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL NO. 8 within the UMATILLA RIVER BASIN for SUPPLEMENTAL IRRIGATION OF 6.0 ACRES.

This right was perfected under Permit G-3822. The date of priority is FEBRUARY 15, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.075 CUBIC FOOT PER SECOND (if available at the original point of appropriation described as Well No. 2, located within the NE1/4 SE1/4, Section 27, T 4 N, R 27 E, W.M.; 1420 feet North and 490 feet West from the SE corner of Section 27), or its equivalent in case of rotation, measured at the well.

The well is located as follows:

WELL #8: SW 1/4 NW 1/4, SECTION 26, T 4 N, R 27 E, W.M.; 1160 FEET NORTH AND 370 FEET EAST FROM THE W 1/4 CORNER, SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 SW 1/4 6.0 ACRES
SECTION 27
TOWNSHIP 4 NORTH, RANGE 27 EAST, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.


The water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered NOVEMBER 24, 2004, and together with Certificate 80916 supersedes Certificate 80594, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
