The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.55 CUBIC-FOOT PER SECOND, if available at the original point of diversion, SE4 NE4, SECTION 36, T 15 S, R 15 E, WM; S 9° 20' W, 28.55 CHAINS FROM THE NE CORNER, SECTION 36, or its equivalent in case of rotation, measured at the point of diversion from the source.
