confirms the right to use the waters of the CROOKED RIVER AND PRINEVILLE RESERVOIR CONSTRUCTED UNDER PERMIT 2223, a tributary of the DESCHUTES RIVER, for SUPPLEMENTAL IRRIGATION OF 127.0 ACRES.

This right was perfected under Permit 25991. The date of priority is April 8, 1914. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.17 CUBIC-FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

PRINEVILLE RESERVOIR - SW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 11, T 17 S, R 16 E, WM;
1650 FEET SOUTH AND 300 FEET EAST FROM THE NW CORNER, SECTION 11.

DIRECT DIVERSION 8 - NW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 1, T 16 S, R 15 E, WM; 300
FEET SOUTH AND 470 FEET EAST FROM THE N $\frac{1}{4}$ CORNER, SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, (or its equivalent) and 4.0 acre-feet for each acre irrigated during the irrigation season of each year, from direct flow and storage from the reservoir constructed under Permit R-2223, and shall be further required to have a contract between the landowners and the Bureau of Reclamation.


This certificate is issued in accordance with OAR 690-380-6010(6) to confirm the water right for a non-completed change in point of diversion approved by an order of the Water Resources Director entered August 26, 1993, at Special Order Volume 47, Page 320, approving Transfer 6192, and together with Certificate 68327, supercedes Certificate 57614, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
