## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MILL CREEK, tributary to the COLUMBIA RIVER for IRRIGATION of 11.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 8, at Page 119. The date of priority is 1855.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed ONE-SIXTIETH OF A CUBIC FOOT PER SECOND PER ACRE DURING THE IRRIGATION SEASON FROM APRIL 1<sup>ST</sup> TO OCTOBER 1<sup>ST</sup>, if available at the ORIGINAL point of diversion:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The types and plans of the headgates and measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered APRIL 8, 1992, at Special Order Volume 46, Page 193, approving Transfer Application 6435, and together with certificate 67254, supersedes certificate 5713, State Record of Water Right Certificates.

Said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of water is restricted to the lands and place of use here in described.
