CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GLENN WICKS RT 1 BOX 64 CRESWELL OR 97426

confirms the right to use the waters of COAST FORK WILLAMETTE RIVER, tributary to WILLAMETTE RIVER, for PRIMARY IRRIGATION of 24.1 ACRES and SUPPLEMENTAL IRRIGATION of 4.7 ACRES.

This right was perfected under Permit S-27754. The date of priority is DECEMBER 14, 1961. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.30 CUBIC FOOT PER SECOND (cfs) for PRIMARY IRRIGATION and 0.06 CFS for SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year provided further that the right to use of water is limited to the period when the flow of the Coast Fork Willamette River is more than 135 cfs at its mouth. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:
