A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This right was perfected under Permit 13847. The date of priority is MAY 23, 1939. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.30 CUBIC FEET PER SECOND, if lawfully available at the original point of diversion: NW4 NW4, AS PROJECTED WITHIN COOPER DLC 53, SECTION 10, T 5 S, R 3 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LAMBERT SLOUGH: LOT 2 (NE4 NW4), SECTION 34, T 5 S, R 3 W, W.M.; 1600 FEET SOUTH AND 510 FEET EAST FROM NE CORNER, MATHENY DLC 38.
