confirms the right to use the waters of A WELL, within the McKAY CREEK BASIN for the IRRIGATION of 4.71 ACRES.

This right has been perfected under Permit G-9429. The date of priority is JUNE 4, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.06 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW ¼ SW ¼, SECTION 34, T. 2 N, R. 32 E, W.M.; 915 FEET NORTH AND 870 FEET EAST FROM THE SW CORNER OF SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
