CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of NORTH MYRTLE CREEK, tributary to MYRTLE CREEK, for IRRIGATION OF 8.0 ACRES AND DOMESTIC USE FOR ONE FAMILY.

This right was perfected under Permit S-47919. The dates of priority are JULY 13, 1983 FOR 0.069 CUBIC FOOT PER SECOND (CFS) AND AUGUST 11, 1983 FOR 0.036 CFS. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.105 CUBIC FOOT PER SECOND (CFS), BEING 0.100 CFS FOR IRRIGATION AND 0.005 CFS FOR DOMESTIC USE FOR ONE FAMILY, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
