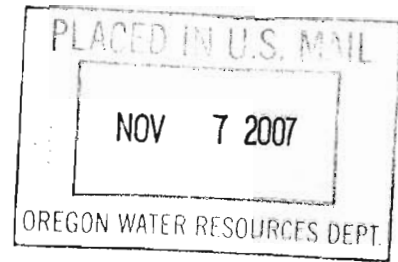

CERTIFICATE OF WATER RIGHT



THIS CERTIFICATE ISSUED TO

OREGON TRAIL MOUNTAIN SPRING WATER; HOLMAN, KEN
51244 OREGON TRAIL RD
NORTH POWDER OR 97867

confirms the right to use the waters of PARKER SPRING, a tributary to Wolf Creek, for INDUSTRIAL USE.

This right was perfected under Permit S-53692. The date of priority is SEPTEMBER 23, 1998. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.223 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The period of allowed use is November 1 through November 30 and January 1 through the month of February of each year.

A description of the place of use to which this right is appurtenant is as follows:

Measurement, recording and reporting conditions:

- A. The water user measures water use based on production output of the bottling plant. In the future, the water user may be required to install and maintain a meter for measuring and recording the quantity of water diverted. The water user shall maintain the meter or alternative measuring device in good working order.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

- C. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

In the event of a request for a change in point of appropriation, an additional point of appropriation or alternation of the appropriation facility associated with this authorized diversion, the quantity of water allowed herein, together with any other right, shall not exceed the capacity of the facility at the time of perfection of this right.


Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
