CERTIFICATE OF WATER RIGHT

This is to Certify, That TERESA SCOTT

of Jordan Valley

, State of

Oregon

has a right to the use of

the waters of Jordan and Trout Creeks for Tract #1; Mahogany Creek for Tracts #2, 3, and 4

for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Nalhour County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 9, at page 1; that the priority of the right thereby confirmed dates from 1873 for Tract #1; 1879 for Tract #2; 1887 for Tract #3; 1901 for Tract #4

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2 acre feet per acre prior to June 1st, and ½ acre foot per acre during any calendar month efter June 1st, of each irrigation season from April 1st to October 15th.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

TRACT #1: Lot 2, Block 2, Pioneer Addition to Town of Jordan Valley, Oregon.

(Being in the SEISE; Section 2, T. 30 S., R. 46 E., W.M.)

- TRACT #2: 17.6 acres in NEWET, 5.4 acres in NWWET, Section 20, T. 28 S., R. 45 E., W.M., being a total of 21 acres.
- TRACT #3: 1 acre in NW#NE1, 1 acre in NE#NE1, 17.1 acres in SWNE1, 3.6 acres in SENE1, 3 acres in SENW1, 8 acres in NEISW1, Section 20, 7.7 acres in SELSE1, Section 19, 30.2 acres in NEINE1, 5.4 acres in NWNE1, Section 30, T. 28 S., R. 45 E., W.M., being a total of 77 acres.
- TRACT #4: 7.2 acres in SENWA, 14.4 acres in NEISWA, 14 acres in NWASWA, 26.6 acres in SWASWA, 2.4 acres in SEASWA, Section 20, T. 28 S., R. 45 E., W.M., being a total of 64.6 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
