CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TAYLOR WESTSIDE RANCH INC. C/O CORNELIUS TAYLOR 21732 HIGHWAY 395 LAKEVIEW OR 97630

confirms the right to use the waters of COX CREEK AND ENLARGEMENT OF WHITE ROCK RESERVOIR, CONSTRUCTED UNDER PERMIT R-6507, TRIBUTARIES OF THOMAS CREEK, for IRRIGATION OF 86.70 ACRES AND SUPPLEMENTAL IRRIGATION OF 244.50 ACRES.

This right was perfected under Permit 40829. The date of priority is DECEMBER 22, 1975. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 8.28 CUBIC FEET PER SECOND (CFS), BEING 2.17 CFS FROM COX CREEK AND 6.11 CFS FROM THE ENLARGEMENT OF WHITE ROCK RESERVOIR, or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
