CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RONALD T. WILLIAMS

KLAMATH FALLS, OR 97601

confirms the right to use the waters of an unnamed stream and two reservoirs (perfected under permit R-2286) tributaries of Lost river for the purpose of irrigation of 27.0 acres and stock.

This right was perfected under Permit S-26405. The date of priority is August 19, 1959. The amount of water for which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.69 cubic foot per second being 0.02 cfs for stock and 0.67 for irrigation or its equivalent in case of rotation measure at the point of diversion from the stream. The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-2286 and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed and to which such right is appurtenant is as follows:
