CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Wilson Family Ranches
P O Box 209
North Powder, OR 97867

confirms the right to use the waters of Anthony Creek, a tributary of North Powder River, a tributary of Powder River for irrigation of 175.0 acres.

This right was perfected under permit 828.

The date of priority is JUNE 26, 1911.

The use is limited to 2.19 cubic feet per second measured at the point of diversion from the source. The amount of water used for irrigation is limited to a diversion of one-eightieth of one cubic foot per second per acre, or its equivalent, for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The point of diversion is located as follows:

A-20 Lone Pine Ditch NW¼ SW¼, Section 17, T6S, R38E, WM; 100' East and 300' South from the West quarter corner of Section 17, T6S, R38E, WM.

A description of the place of use to which this right is appurtenant is as follows:


Location descriptions are based on the Willamette Meridian.
