CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of Wolf Creek, Dry Creek (aka Peach Cr.), and Shaw Brandt Reservoir, tributaries of Powder River for irrigation of 393.0 acres and storage from Dry Creek (aka Peach Cr.) in the Shaw Brandt Reservoir for 9.0 acre feet.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 6, at Page 291.

The date of priority is 1896.

The use is limited to 9.82 cubic feet per second or its equivalent in case of rotation. The amount of water used for irrigation is limited to an amount actually, beneficially used for said purpose and shall not exceed a diversion of one-fortieth of one cubic foot per second per acre, or its equivalent, and shall be subject to all other conditions and limitations contained in said decree.

The points of diversion are located as follows:

WC-01A	W1 Pipeline	SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 11, T6S, R38E, WM; 657' North and 952' West from the Southeast corner of Section 11, T6S, R38E, WM.
D-01	Dry Cr. (aka Peach Cr.) Ditch	SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 25, T5S, R39E, WM; 440' West and 650' North from the East quarter corner, Section 25, T5S, R39E, WM.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
