confirms the right to use the waters of Wolf Creek, a tributary of Powder River for irrigation of 38.0 acres.

This right was perfected under permit 8514.

The date of priority is MAY 4, 1928.

The use is limited to 0.48 cubic feet per second, or its equivalent in case of rotation, measured at the point of diversion from the source. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-eightieth of one cubic foot per second per acre, or its equivalent, for each acre irrigated during the irrigation season of each year.

The point of diversion is located as follows:

WC-01B MaHarry Blevins P2 Pipeline SE¼ SE¼, Section 11, T6S, R38E, WM; 657' North and & 952' West from the Southeast corner of Section 11, T6S, R38E, WM.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
