The use is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 11.58 cubic feet per second from March 1st to July 1st and 5.79 cubic feet per second from July 1st to October 1st of each year.

The total quantity diverted during each irrigation season not to exceed 1158.00 acre feet.

The points of diversion are located as follows:

N-12 Kelsey Wilson Ditch

SE½ SW½, Section 36, T6S, R38E, WM; 2450' East and 950' North from the Southwest corner of Section 36, T6S, R38E, WM.
