CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Dodson, Don 51407 OR Hwy 237 North Powder, OR 97867

confirms the right to use the waters of North Powder River, a tributary of Powder River for irrigation of 54.0 acres.

This right was perfected under permit 45715.

The date of priority is MAY 26, 1982.

The use is limited to 1.35 cubic feet per second, during the period of March 1, through June 30, and 0.68 cubic feet per second, during the period of July 1, through September 30, or its equivalent in case of rotation, measured at the point of diversion from the source. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-fortieth of one cubic foot per second per acre during the period of March 1, through June 30, and a diversion of one-eightieth of one cubic foot per second per acre, or its equivalent, during the period of July 1, through September 30, for each acre irrigated during the irrigation season of each year. The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The points of diversion are located as follows:

N-22 Holmes Ditch

NE¹/₄ SE¹/₄, Section 22, T6S, R39E, WM; 624' South and 795' West from the East quarter corner of Section 22, T6S, R39E, WM.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
