# CERTIFICATE OF WATER RIGHT

#### THIS CERTIFICATE ISSUED TO

Dodson, Don 51407 OR Hwy 237 North Powder, OR 97867

confirms the right to use the waters of Wolf Creek, a tributary of Powder River for irrigation of 25.0 acres.

This right was perfected under permit 2173.

The date of priority is OCTOBER 14, 1911.

The use is limited to 0.31 cubic feet per second, or its equivalent in case of rotation, measured at the point of diversion from the source. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-eightieth of one cubic foot per second per acre, or its equivalent, in case of rotation, for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The points of diversion are located as follows:

WC-01A, W1 Pipeline SE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, Section 11, T6S, R38E, WM; 657' North and 952' West from the Southeast corner of Section 11, T6S, R38E, WM.

WC-07, Sunnyslope Ditch SW¼ NW¼, Section 16, T6S, R39E, WM; 400' East and 2260' South from the Northwest corner of Section 16, T6S, R39E, WM.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of diversion, together with the diverted at the original Sunnyslope and Kelsey-Moore Ditch at Wolf Creek, shall not exceed the quantity of water available at the original point of diversion.

The quantity of water diverted from Wolf Creek shall be no more than 95% of the water that was historically used from the North Powder River under the former primary right.

This certificate confirms an order of the Water Resource Director entered on, MAY 17 2011, and recorded in Special Order Volume 34. Page 100, approving a petition by Powder Valley Water Control District under ORS 541.329 for mapping water rights within a district.

This certificate together with Certificate 83811 supersedes Certificate 72195.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described.
