CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Dodson, Don
51407 OR Hwy 237
North Powder, OR 97867

confirms the right to use the waters of Wolf Creek, a tributary of Powder River for irrigation of 110.00 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 6, at Page 291.

The date of priority is 1879.

The use is limited to 2.75 cubic feet per second or its equivalent in case of rotation. The amount of water used for irrigation is limited to an amount actually, beneficially used for said purpose and shall not exceed a diversion of one-fortieth of one cubic foot per second per acre, or its equivalent, and shall be subject to all other conditions and limitations contained in said decree.

The points of diversion are located as follows:

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

WC-11 Walk SE¼ NE¼, Section 15, T6S, R39E, WM; 1140' West and 2930' North from the Southeast corner of Section 15, T6S, R39E, WM.


