confirms the right to use the waters of North Powder River, a tributary of Powder River for irrigation of 63.8 acres, livestock and domestic.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 3, at Page 252.

The use is limited to 1.60 cubic feet per second from March 1st to July 1st and 0.80 cubic foot per second from July 1st to October 1st of each year. The total quantity diverted during each irrigation season not to exceed 159.75 acre feet.
