CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Spratling, Martha Jane, TTEE 46363 Schoolhouse Rd. Haines, OR 97833

confirms the right to use the waters of North Powder River, a tributary of Powder River for irrigation of 123.5 acres.

This right was perfected under permit 3041.

The date of priority is JULY 26, 1916.

The use is limited to 1.54 cubic feet per second, or its equivalent in case of rotation.

The points of diversion are located as follows:

N-14 Smith McPhee Tanner Ditch

NW¼ SW¼, Section 32, T6S, R39E, WM; 1500' North and 500' East from the Southwest corner

of Section 32, T6S, R39E, WM.

N-14A McPhee Ditch

NW¼ NW¼, Section 33, T6S, R39E, WM; 300' East and 1000' South from the Northwest corner

of Section 33, T6S, R39E, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-eightieth of one cubic foot per second per acre, or its equivalent, for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described.
