This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 6, at Page 291.

The use is limited to 3.45 cubic feet per second or its equivalent in case of rotation.

The amount of water used for irrigation is limited to an amount actually beneficially used for said purpose and shall not exceed a diversion of one-fortieth of one cubic foot per

second per acre, or its equivalent, and shall be subject to all other conditions and limitations contained in said decree.
