CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of Wolf Creek, a tributary of Powder River for irrigation of 138.0 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 6, at Page 291.

The dates of priority are:

The use is limited to 3.45 cubic feet per second or its equivalent in case of rotation.

The points of diversion are located as follows:

WC-02 Gilkison Ditch SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 11, T6S, R38E, WM; 240' North and 200' West from the Southeast corner of Section 11, T6S, R38E, WM.

WC-04 Moody Ditch NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 18, T6S, R39E, WM; 2290' West and 1230' South from the Northeast corner of Section 18, T6S, R39E, WM.

WC-05 Gorham Ditch NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 18, T6S, R39E, WM; 2290' West and 1230' South from the Northeast corner of Section 18, T6S, R39E, WM.

The amount of water used for irrigation is limited to an amount actually beneficially used for said purpose and shall not exceed a diversion of one-fortieth of one cubic foot per

second per acre, or its equivalent, and shall be subject to all other conditions and limitations contained in said decree.

A description of the place of use to which this right is appurtenant is as follows:


Location descriptions are based on the Willamette Meridian.

Gorham, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on MAY 17 2011, and recorded in Special Order Volume 84, page 100 approving a petition by the Powder Valley Water Control District under ORS 541.329.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

This certificate together with Certificate 83747 supercedes Certificate 7568.
