confirms the right to use the waters of Wolf and Dry Creeks and Shaw-Brandt Reservoir, tributaries of Powder River for irrigation of 126.5 acres; and storage from Dry Creek in Shaw-Brandt Reservoir.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 6, at Page 291.

The date of priority is 1896.

The use is limited to 3.2 cubic feet per second or its equivalent in case of rotation from Wolf and Dry Creek.

The points of diversion are located as follows:

D-01 Dry Cr.(Peach Cr.) Ditch

SE1/4 NE1/4, Section 25, T5S, R39E, WM

Shaw Brandt Ditch

NW1/4 NW1/4, Section 11, T6S, R38E, WM

Shaw Brandt Reservoir

NW1/4 NW1/4, Section 32, T5S, R39E, W.M.

The amount of water used for irrigation is limited to an amount actually beneficially used for said purpose and shall not exceed a diversion of one-fortieth of one cubic foot per second per acre, or its equivalent, and shall be subject to all other conditions and limitations contained in said decree.
