CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Dodson, Don & Jessie 51407 OR Hwy 237 North Powder, OR 97867

confirms the right to use the waters of Waste Water from Daugherty Field for irrigation of 7.5 acres and North Powder River for irrigation of 17.2 acres and supplemental irrigation of 7.5 acres, tributaries of Powder River.

This right was perfected under permit 13070.

The date of priority is MARCH 14, 1938.

The use is limited to 0.19 cubic foot per second from Waste Water from Daugherty Field for irrigation and 0.43 cubic foot per second from North Powder River for irrigation and up to 0.19 cubic foot per second from North Powder River for supplemental irrigation when Waste Water is not available, provided that the total quantity shall not exceed 0.62 cubic foot per second, or its equivalent in case of rotation.

The points of diversion are located as follows:

N-22 Holmes Ditch NE

NE1/4 SE1/4, Section 22, T6S, R39E, WM; 624' South and 795'

West from the East quarter corner of Section 22, T6S, R39E,

WM.

UnSt -01 Waste Water

SE¼ SW¼, Section 14, T6S, R39E, WM; 867' North and 688'

West from the South guarter corner of Section 14, T6S, R39E,

WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-fortieth of one cubic foot per second per acre, or its equivalent, for each acre irrigated from March 1, to July 1, and one-eightieth of one cubic foot per second per acre from July 1 to October 1, during the irrigation season of each year, and shall also be limited to the water available at the proposed point of diversion and shall not carry with it the right to compel the continuance of the waste water.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Location descriptions are based on the Willamette Meridian.

The provisions of this certificate are subject to the stipulation of September 25, 1942, between North Powder Milling and Mercantile Company by Chris E. Johnson, Vice President, and Violet Parker and subject especially to the following clause in that stipulation: "Diversion of water from the tail race of the North Powder Milling and Mercantile Company for use on the lands herein described is limited to such times as water is flowing in said tail race by authority of said Company, its agents, licensees, successors or assigns."

This certificate describes that portion of the water right confirmed by Certificate 14421, issued in the name of Violet Parker, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on MAY 1 7 2011, and recorded in Special Order Volume 4, page 166 approving a petition by the Powder Valley Water Control District under ORS 541.329.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described.

This certificate together with Certificate 83758 supercedes Certificate 14421.
