## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

Dodson, Don D 51407 or Hwy 237 North Powder, OR 97867

confirms the right to use the waters of North Powder River, a tributary of Powder River for irrigation of 17.9 acres.

This right was perfected under permit 45715.

The date of priority is MAY 26, 1982.

The right is limited to not more 0.45 Cubic Foot per Second (cfs) from March 1 to June 30 and 0.23 cfs from July 1 to September 30 for irrigation and 0.5 cfs for Livestock, or its equivalent in case of rotation measured at the point of diversion from the source.

The points of diversion are located as follows:

N-22 Holmes Ditch NE¼ SE¼, Section 22, T6S, R39E, WM; 624' South and 795' West from the East quarter corner of Section 22, T6S, R39E, WM.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-fortieth of one cubic foot per second (cfs) per acre, or its equivalent, for each acre irrigated from March 1, to July 1, and one-eightieth of one cfs per acre from July 1 to October 1, during the irrigation season of each year, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that during the irrigation season the water for livestock shall be a part of that diverted for irrigation and shall not at any time exceed 0.5 cfs.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described.

This certificate together with Certificate 83769 supercedes Certificate 62276.
