CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Miles, Myron Rt 1, Box 651 North Powder, OR 97867

confirms the right to use the waters of North Powder River, a tributary of Powder River for irrigation of 6.1 acres and supplemental irrigation of 274.3 acres.

This right was perfected under permit 46184.

The date of priority is NOVEMBER 2, 1981.

The use is limited to 6.7 cubic feet per second, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

N-23 Peterson Ditch NE¼ SE¼, Section 22, T6S, R39E, WM; 1820' North and 800' West from the Southeast corner of Section 22, T6S, R39E, WM.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of one-fortieth of one cubic foot per second per acre, or its equivalent, for each acre irrigated from March 1, to July 1, and one-eightieth of one cubic foot per second per acre from July 1 to October 1, during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herin. The lands described as supplemental to certificate 9398 are hereby granted a primary right during the months of July and August.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The use IS* denotes a right supplemental to certificate 9398 and is a primary right during the months of July and August.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described.

This certificate together with Certificate 83771 supercedes Certificate 65022.
