## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Dodson, Don & Jessie 51407 OR Hwy 237 North Powder, OR 97867 Harrod, Zelda 51684 Hwy 237 North Powder, OR 97814

confirms the right to use the waters of Wolf Creek, tributary of Powder River for irrigation of 247.5 acres.

This right was perfected under permit 2173.

The date of priority is OCTOBER 14,1911.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.10 cubic feet per second, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WC-01A W1 Pipeline	SE¼ SE¼, Section 11, T6S, R38E, WM; 657' North and 952' West from the Southeast corner of Section 11, T6S, R38E, WM.
WC-07 Sunnyslope Ditch	SW¼ NW¼, Section 16, T6S, R39E, WM; 400' East and 2260' South from the Northwest corner of Section 16, T6S, R39E, WM

The amount of water used for irrigation is limited to a diversion of one-eightieth of one cubic foot per second per acre, or its equivalent, for each acre irrigated during the irrigation season of each year, or its equivalent in case of rotation.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the new point of diversion, together with that diverted at the original Sunnyslope and Kelsey-Moore Ditches at Wolf Creek shall not exceed the quantity of water available at the original point of diversion.

The quantity of water diverted from Wolf Creek shall be no more than 95% of the water that was historically used from the North Powder River under the former primary right.

This certificate describes that portion of the water right confirmed by Certificate 72195, issued in the names of Don Dodson, Louise Dodson and Zelda Joy Harrod, not modified by the provisions of an order of the Water Resources Director entered on <u>MAY 172011</u>, and recorded in Special Order Volume <u>84</u>, page <u>100</u>, approving a petition by the Powder Valley Water Control District under ORS 541.329.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described.

This certificate together with Certificate 83773 supercedes Certificate 72195.
