CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Powder Valley Water Control District
P.O. Box 189
North Powder, OR 97867

confirms the right to use the waters of Rock Creek, tributary of Powder River for irrigation of 339.4 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 6, at Page 291.

The date of priority is 1888.

The points of diversion are located as follows:

R-08A NPR-RC NE¼ SW¼, Section 34, T7S, R38E, WM; 3040' South and 3102'
Pipeline (Rock Cr.) West from the Northeast corner of Section 34, T7S, R38E, WM.

R-19 Miller Ditch SW¼ NE¼, Section 35, T7S, R38E, WM; 2700' East and 1800' South
from the Northwest corner of Section 35, T7S, R38E, WM.

The amount of water used for irrigation is limited to an amount actually beneficially used for said purpose and shall not exceed a diversion of one-fortieth of one cubic foot per second per acre, or its equivalent, and shall be subject to all other conditions and limitations contained in said decree.

A description of the place of use to which this right is appurtenant is as follows:
