CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

U. S. BUREAU OF RECLAMATION

confirms the right to use the waters of PRINEVILLE RESERVOIR, tributary to CROOKED RIVER, for SUPPLEMENTAL IRRIGATION of 122.7 ACRES.

This right was perfected under Permit S-25991. The date of priority is APRIL 8, 1914. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 3.06 CUBIC FEET PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from the reservoir constructed under Permit R-2223, and shall be further required to have a contract between the landowners and the Bureau of Reclamation.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate describes that portion of the water right confirmed by Certificate 83443, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAR 07 2008, approving Transfer Application T-9172.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
